- 4. Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp only on the or before 16-01-2020 12:00 Hrs..
- 5. Online bids shall be opened in the presence of bidder representative who choose to attend on 16-01-2020 13:00. at the office of Rural Municipal Executive, Palpa. Online bid must be valid security for a period of 90 days counting after the day of bid opening and must be accompanied by bid security, amounting to a minimum of NRs.2,50,000.00 which shall be valid for minimum 30 days beyond the bid validity period .The scan copy of bid security should be uploaded in the e-GP system during bid submission.
- 6. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit 'Dharauti' Account No. 3030303007110 of 'Ribdikot Rural Munacipality' Palpa in Rastriya Banijay Bank, Tansen, Palpa and submit bank deposit voucher along with the bid.
